



ILLINOIS IS MAKING DRAMATIC PROGRESS AGAINST HIV.

New HIV cases have dropped by 28% from 2008 to 2017 and mother-to-child HIV transmission has been nearly eliminated. There were 752 new HIV cases in Chicago in 2017 and 614 new HIV cases elsewhere in the state: the lowest number in two decades.

BUT NOT ALL GROUPS ARE BENEFITTING EQUALLY.

Black gay men are experiencing an increase in HIV cases, particularly among youth. Black women account for more than 73% of women who are newly diagnosed and women who are living with HIV. New HIV cases in the Latinx community rose 13% outside Chicago between 2006 and 2017.

ILLINOIS CAN GET TO ZERO...

Expand HIV viral suppression by 20 percentage points



Help Illinoisans living with HIV/AIDS thrive and prevent new HIV transmissions (U=U)

Increase PrEP usage by 20 percentage points among people who will most benefit



Prevent new HIV infections, especially among communities most impacted

Secure and improve access to the Affordable Care Act for all Illinoisans



Improve health care, especially for the 67% of Illinoisans living with HIV/AIDS who are on Medicaid or Marketplace plans

GTZ-IL committees will solicit community feedback on our draft plan. In 2019, GTZ-IL committees will adjust the draft plan based on that feedback, finalize and then release the plan to be implemented across the state.

HEALTH CARE
Enhance care and increase access for people living with and vulnerable to HIV/AIDS

WORKFORCE
Foster new approaches and adapt to evolving needs

EQUITY
End health disparities associated with race, ethnicity, sexual and gender identity, age, residency status, and lived experiences

EFFICIENCY
Coordinate activities to expand the reach of necessary services, and strengthen the HIV service delivery system

LINKED CONDITIONS
Increase access to treatment for mental health, substance use, STIs and viral hepatitis

SURVEILLANCE
Improve data gathering, sharing and exploration to benefit systems of care
